## NORTH TURTON PARISH COUNCIL

Minutes of the meeting held on Monday 1 December 2025  
In the Library at The Barlow, Bolton Road, Edgworth

**Present:** Councillor D Wild (in the Chair)  
Councillors J Rigby, D Hey, K Harrison, D Crompton, A Highton and J Rowley  
**Also present:** J Smith (Clerk) and 1 member of the public  
**Apologies:** None

*Prior to the meeting members of the public were given an opportunity to speak.*

*Phil Broughton from Edgworth & District Horticultural Society (EDHS) was present to again discuss the situation regarding the planters that were removed earlier in the year. Phil explained that the Lengthsman had dropped off 20 planters with some bulbs that were left in them, but the bulbs were not as damaged as the Parish Council had led them to believe and none of the planters were broken. After a conversation between Jean Turner and the Chair, the EDHS has purchased 3 planters together with 10 bags of compost and bulbs which are to be delivered imminently. The Horticultural Society will arrange for 2 of the planters to be filled and placed either side of the stone bus shelter on the crossroads and the other planter to be filled and placed near the glass bus shelter. With regard to the original planters, the HS will purchase additional compost and bulbs for those and place some of them back in front of businesses and homes who will look after them, but the Parish Council will ask the Lengthsman to water them if the weather is particularly warm and they are looking a bit weary. The HS will arrange to send the Parish Council an invoice for 50% of the costs incurred. The Chair thanked EDHS for organising the planters and again apologised for not consulting with them before the original planters were removed and asked to draw a line under the situation now as it has been ongoing for months.*

*Phil Broughton also asked about the sign for Chapeltown Community Garden that has yet to be erected. The Clerk agreed to contact the Lengthsman and ask him to arrange for it to be put up as soon as possible.*

### 8436 Matters Arising from previous minutes

*Telephone Kiosks – Yvette Browne from North West Ambulance Service was again invited to attend this meeting to discuss possible funding for a defibrillator in the telephone kiosk at Entwistle Station, but unfortunately she was again unavailable.*

*Turton Tower defibrillator – unfortunately Turton Tower are unable to find a suitable place to instal the defibrillator so it is to be returned.*

*Maria Square – Cllr Wild explained the tree contractor is away now for a couple of weeks but is hoping the work will be completed on his return.*

*Rivington Road, Belmont* – Cllr Harrison’s original appeal against the reply he received from Lancashire Constabulary Data Protection Office was rejected and he is now going to appeal again.

## **8445 Any Other Business**

*Belmont School* – Cllr Harrison had received an enquiry from the Head at Belmont Primary School who explained the Governors are exploring the engagement of a lollipop person on High Street as part of the traffic calming measures in the village.

*North Turton Trail* – Clerk has added the details of the trail to the Parish Council website together with links to the Ordnance Survey website. Cllr Hey has now walked the trail and will contact Roger Binks about making a couple of slight alterations.

*Chapeltown* – Cllr Rowley updated the Parish Council on the recent roadside speed monitoring session in Chapeltown on Saturday 29 November. Over a 2-hour period 110 vehicles were clocked with an average speed of between 28-32mph. More sessions will take place with the hope of eventually achieving a 20mph zone through Chapeltown.

*Rivington Road car park* – there have been reports of litter being left on the car park at Hordern Stoops and the Clerk to contact United Utilities to ask if a bin could be provided.

*Christmas lights 2026* – there could be an issue with the times for next year's lights switch-on in Chapeltown & Edgworth, but the Clerk will keep the Parish Council informed.

*Update on Local Government Reorganisation* – Cllr Harrison asked if this item could be added to the agenda for the next meeting and Cllr Rigby agreed to get an update for the January meeting.
