## **NORTH TURTON PARISH COUNCIL**

Minutes of the meeting held on Monday 2 June 2025  
In The Library, The Barlow, Bolton Road, Edgworth

**Also present:** J Smith (Clerk) and 2 members of the public

*Prior to the meeting members of the public were given an opportunity to speak.*

*Mike Phillips attended the meeting to inform the Parish Council that BVRA have met with a funding co-ordinator through BwDBC and are applying for lottery funding for the Community Garden. Their bid should be sent through within the next 6 weeks and they are applying for around £20k. The Parish Councillors wished them well with their bid.*

*Mr Grimwood attended the meeting to advise the Parish Council that the planters at the top of Hob Lane have been filled up and a cheque to re-imburse him was signed and given to him. He thanked the Parish Council for their contribution.*

### **8363 Matters Arising from previous minutes**

*Ryecroft Lane* – Clerk sent another e-mail to Martin Kelly on 19 May and copied in Cllr Rigby. Will speak to Cllr Rigby and ask her to chase him for a reply.

*Chapeltown Community Garden* – Cllr Wild brought the completed signage for the Garden – Clerk to contact the Lengthsman and ask him to collect it and attach to the wall. Cllr Rowley agreed to help if the Lengthsman has any queries where to place it.

*Refuse bins in Belmont* - Cllr Crompton spoke to the resident but he is not interested in the bins being on his land. There is also an issue with rubbish/fly tipping on the layby on the way to Tockholes. Agreed to write to BwDBC to ask for a solution to the problems.

*Toilet Block rendering* – one quote has been received but Cllr Wild is arranging for another quote to be done but the contractor wouldn't be able to complete the job before the end of June – agreed the rendering is reliant on the weather and could wait until later in the year as long as it was completed before the cold weather.

*Insurance* – Cllr Crompton will complete the up-to-date valuation of the toilet block in Belmont.

*Dog poo bins* – Lengthsman has installed the bin at the end of the dam in Belmont. Clerk has ordered a new dog poo bin for the top of Harbour Lane – given to Lengthsman to be put up.

*Waterwheel* – 2 companies came to have a look at cleaning the waterwheel before it is painted – one of the companies completed the job at no charge to the Parish Council.

*Turton Trail* – Clerk had been e-mailed again by Roger Binks regarding the re-publication of the Turton Trail leaflet. Clerk directed the e-mail to Cllr Hey who has contacted PNFS to see if anyone is aware of how a leaflet could be published, and by whom. Could also create the route in the Ordnance Survey app and set up a link on the Parish Council website. Roger Binks agreed to walk the route again and provide an up-to-date description for the app.

*Planters across Edgworth* – Cllrs Crompton & Highton are looking into a scheme to sponsor planters across Edgworth – they will look into the cost of this and come back to the Parish Council.

**10/25/0552      Non-Material Amendment Proposal: Non-material amendment pursuant to planning application 10/24/0135 "Erection of raised decked area from first floor of property and insertion of roof lights within front and rear roof slopes" - change material to raised deck balustrade at 36 South View, Belmont**

The Parish Council has no objection to this proposed development.
