# NORTH TURTON PARISH COUNCIL

Minutes of the meeting held on Monday 3 November 2025 In the Library at The Barlow, Bolton Road, Edgworth

**Present:** Councillor D Wild (in the Chair)

Councillors J Rigby, D Hey, K Harrison, D Crompton and J Rowley

**Also present:** J Smith (Clerk) and 1 member of the public

**Apologies:** Councillor A Highton

Prior to the meeting members of the public were given an opportunity to speak.

Jean Turner from Edgworth & District Horticultural Society (EDHS) was present to discuss what arrangements are to be made about replacing the planters across Edgworth that were removed by the Lengthsman at the request of the Parish Council earlier in the year. The Chair again apologised for not consulting with EDHS before the planters were removed. Jean raised the possibility of purchasing 2 large self-watering tubs to be placed in a prominent location in the village – maybe near the bus shelter - and asked if the Lengthsman could retrieve any bulbs from the planters he picked up and assess their condition to see if they could be reused. Jean recommended the website Amberol.co.uk for the planters – the Clerk agreed to have a look. The Parish Council offered to speak to the Post Office/Whiteheads/Holdens to see if they would be interested in helping to maintain the planters and the Lengthsman could possibly top up the water reservoirs when he is doing his duties across the village. EDHS agreed to go 50/50 towards the costs with the Parish Council, as they have in previous years. The Parish Council offered to pay £300 towards the cost of buying the planters/plants/bulbs/compost etc if EDHS would match the £300. Cllr Rigby asked if EDHS would take over responsibility for the project, but Jean declined and stated it should be a joint venture with active participation from both parties. Jean agreed to take the proposals to EDHS for their approval and swapped mobile numbers with the Chair.

#### 8427 Matters Arising from previous minutes

Telephone Kiosks – Clerk invited Yvette Browne from North West Ambulance Service to attend this meeting but unfortunately she was unavailable so she has been invited to the meeting in December to discuss possible funding for a defibrillator in the kiosk at Entwistle Station.

Maria Square – Cllr Harrison asked Cllr Wild when he would be available to complete the work on the trees – they agreed to meet on Sunday 9 November in the afternoon. Cllr Harrison to check with the Community Garden if they would be interested in the chippings/mulch.

Rivington Road, Belmont – Clerk has received a reply from the office of Clive Grunshaw, Lancashire Police and Crime Commissioner and Cllr Harrison has received a reply from Lancashire Constabulary Data Protection Office who were unable to provide the requested information as it was deemed to be exempt from disclosure. Cllr Harrison to appeal this.
